

PUBLICITY, DISSEMINATION & COMMUNICATION RULES

for Tecniospring INDUSTRY Beneficiaries and Researchers

The present Publicity, Dissemination and Communication rules aim at summarising all the **rules and conditions** set by the **Regulatory Bases** (RESOLUTION EMC/1917/2019, of 9 July 2019, article 23.2, and RESOLUTION EMC/1446/2020, of 18 June 2020, article 22.2).

We remind you that **dissemination is an obligation**: the beneficiary must — as soon as possible — ‘disseminate’ its results by disclosing them to the public by appropriate means (other than those resulting from protecting or exploiting the results), including in scientific publications.

COMMUNICATION AND THE EUROPEAN COMMISSION

As the Tecniospring INDUSTRY project is co-funded by Horizon 2020, the **Research Executive Agency** and/or the **European Commission** are authorised to publish in any form and in any medium details of the beneficiary institutions.

ACCIÓ is responsible for the communication with the European Commission and the Research Executive Agency (REA). Tecniospring INDUSTRY beneficiaries provide ACCIÓ with all the required information it needs to do so.

GENERAL RULES FOR DISSEMINATION

Unless it is impossible, **all external communication, dissemination and publicity actions**, including conferences and seminars or any other type of information or promotional material (leaflets, dossiers, posters, presentations, etc.), **must display**:

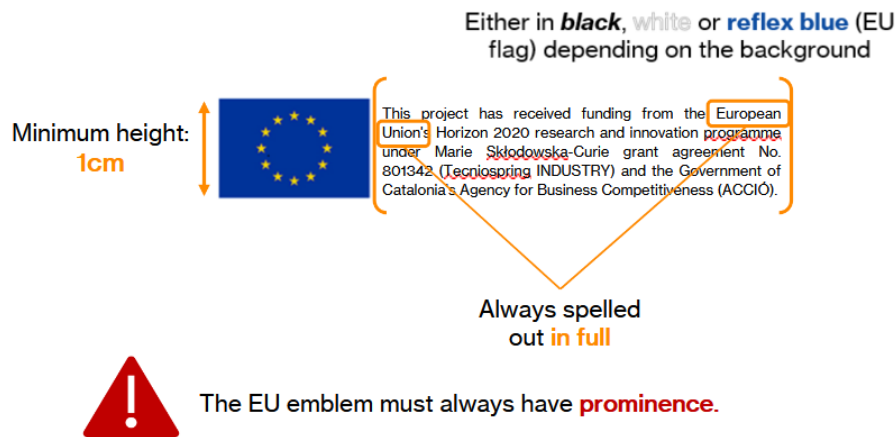
- (1) the **EU emblem**

- (3) **Tecniospring INDUSTRY logo**
- (4) the following **funding declaration**:

USE OF THE EUROPEAN UNION EMBLEM

Be aware that there are some rules regarding the use of the emblem:



*Having prominence means that the EU emblem must be bigger than any other logo, which means that when it appears together with the ACCIÓ and Tecniospring INDUSTRY logos, it must be as follow:
