# 1. Goals and Methodology





#### Goals, methodology and sources of the Directory of Companies in Catalonia with Subsidiaries Abroad

The aim of this directory is to identify the companies in Catalonia that have subsidiaries abroad and to record the characteristics and countries where these subsidiaries are set up.

The information on shareholding percentages, corporate structures and basic data is filed by the companies in the Companies Register of Catalonia and in the other countries where they are set up.

Subsidiaries abroad whose parent company is in Catalonia are companies whose parent company:

- Has a NIF in Catalonia. Its headquarters is therefore in Catalonia
- It holds at least a 10% share of the subsidiary
- The source of its capital is either Catalan or foreign
- Companies in which Catalan private investors (individuals) hold a direct or indirect share of the capital are not considered subsidiaries abroad.
- For some subsidiaries, the fact that the Catalan company has a shareholding is known, but the specific percentage is not known.

Corporate data, shareholding percentages and countries of origin of share capital are calculated from the different sources consulted:

- External sources: ORBIS, INFORMA and company websites.
- Internal sources: EIC specialized press kit, general press clippings by ACCIÓ and CRM by ACCIÓ.
- Company websites.



# 2. Executive Summary





#### Main figures of companies identified in Catalonia in 2022 with subsidiaries abroad

In 2022, there are 3,165 companies in Catalonia with 8,382 subsidiaries abroad.

There was a 0.5% increase in parent companies in Catalonia and a 3.1% increase in subsidiaries compared to 2019 (before the pandemic).

48.2% of parent companies in Catalonia with subsidiaries abroad are located in Barcelonès and, with the parent companies located in Baix Llobregat, Vallès Occidental, Vallès Oriental and Maresme, they account for 80.3% of the total.

83.4% of parent companies in Catalonia and 92.9% of subsidiaries abroad are SMEs and invoice less than 50 M euros.

50% of subsidiaries abroad are located in Europe and 38% in the Americas. Subsidiaries in North America increased by 10.7% compared to 2019.

30% of parent companies in Catalonia are in the service sector, 19.5% in manufacturing and 18.1% in the commercial sector. In terms of turnover, parent companies in manufacturing stand out (34.1%).

13.1% of parent companies in Catalonia with subsidiaries abroad work in technological fields.

As for the sectorial distribution by turnover volume, companies from the food sector (11.8% of the total) stand out, as well as those from other sectors such as infrastructure and construction (10.6%), finance and insurance (10.4%) and pharmaceutical industry (8.9%).

3. The importance and features of companies in Catalonia with subsidiaries abroad, 2022





#### Size of companies in Catalonia with subsidiaries abroad

83.4% of the companies in Catalonia with subsidiaries abroad are small and medium-sized companies that invoice less than 50 M euros; 59.5% have fewer than 50 workers.


#### The sectors of companies in Catalonia with subsidiaries abroad (I)

In terms of the **number of parent companies** in Catalonia, the infrastructure and construction sectors stand out, as well as services such as consulting, and finance and insurance (36.6% of the total). The main industrial sectors are machinery, chemicals, ICT and food (21.4% of the total number of companies).

13.1% of companies with subsidiaries abroad work in sectors considered **tech fields**.

(\*) Companies working in the following sectors are considered tech companies: TIC and the digital transformation of industry, audiovisual, video games, R&D, biotech, electronics and electrical equipment, health and healthcare services and mobility services.






#### The sectors of companies in Catalonia with subsidiaries abroad (II)

In terms of **turnover**, of note is the importance of parent companies in Catalonia in the food sector (11.8% of the total), infrastructure and construction (10.6%), finance and insurance (10.4%), and the pharmaceutical industry (8.9% of the total).



#### Value chain of companies in Catalonia with subsidiaries abroad

By number of companies, 30% of parent companies in Catalonia are in the service sector, 19.5% in manufacturing and 18.1% in the commercial sector. In terms of turnover, companies in manufacturing stand out (34.1%).

### County distribution of companies in Catalonia with subsidiaries abroad

48.2% of parent companies in Catalonia with subsidiaries abroad are located in Barcelonès and, with the parent companies located in Baix Llobregat, Vallès Occidental, Vallès Oriental and Maresme, they account for 80.3% of the total.

#### Geographic areas where subsidiaries abroad whose parent company is in Catalonia have set up

50% of the subsidiaries abroad are set up in Europe and nearly 40% in Western Europe.

The number of subsidiaries in the Americas accounts for nearly 38% of the total. Subsidiaries in North America increased by 10.7%.

Asia, Africa and Oceania account for 13% of the subsidiaries abroad whose parent company is in Catalonia.

## Countries where subsidiaries abroad whose parent company is in Catalonia have set up

The top 20 countries account for 75.1% of the subsidiaries abroad whose parent company is in Catalonia. The top 10 countries concentrate 57.1% of the subsidiaries.

Portugal is the main country where subsidiaries abroad are set up, with 9.3% of the total, followed by the US (8.7%), Mexico (6.1%), Brazil (6.1%), France (6.0%), Italy (5.6%), the UK (4.7%) and Germany (4.0%).

Although there are not many variations compared to 2019 in terms of positions in the ranking, there is a considerable growth in the number of subsidiaries in the US, Germany, Morocco, Andorra, the UK and Mexico. Subsidiaries in France, Portugal, Romania and Poland report negative variations.






#### European countries where subsidiaries abroad whose parent company is in Catalonia have set up
