## 1. Goals and Methodology



## Goals, methodology and sources of the Directory of Foreign Subsidiaries in Catalonia

ACCIÓ's Directory of Foreign Subsidiaries in Catalonia has two goals:

- To comprehensively identify the subsidiaries of foreign companies with a presence in Catalonia in all business sectors.
- To reflect foreign business activity in Catalonia based on having a presence in Catalonia and correcting the headquarters effect.

ACCIÓ Generalitat de Catalunya

- It includes subsidiaries of foreign companies in which the majority shareholding (50% or more) is in the hands of foreign capital.
- One company is counted for each NIF in the Companies Register (not establishments).
- Companies from **all sectors** of the Catalan economy are included.
- They can be subsidiaries, branches and/or representation offices of foreign companies in Catalonia, as well as all kinds of facilities (e.g. production plants, R&D centres, sales offices), provided they are located in Catalonia.
- Data on shareholding percentages, corporate structure and basic data came from the information deposited

## by companies in the **Companies Register in February 2022**.

- The organization was included when a foreign subsidiary had an operating centre in Catalonia, even if its corporate or fiscal headquarters was outside Catalonia.
- In some cases, there was ambiguity regarding the real source of capital and the nationality of the company headquarters (country where the company is officially registered). Within Europe, this happens to companies registered in Luxembourg, the Netherlands, Ireland and Switzerland, among others. Whenever possible, we tried to identify the ultimate source of the capital.

Corporate data, shareholding percentages and countries of origin of share capital are calculated from the different sources consulted:

- ORBIS (Companies Register), SABI and INFORMA
- CRM by ACCIÓ and information from Trade & Investment Offices
- Financial and
  business press kit
- Company websites




## Evolution of foreign subsidiaries in Catalonia

A total of 9,155 foreign subsidiaries were identified in Catalonia in 2022.

This represents an increase of 2.8% compared to the 8,908 foreign subsidiaries identified in 2019 and an increase of 60.4% compared to the 5,708 identified in 2014.

Foreign subsidiaries account for 18.5% of employment in Catalonia (\*).



Age of foreign subsidiaries in Catalonia, 2022




## The main industries of foreign subsidiaries in Catalonia (number of companies)

### Foreign subsidiaries in Catalonia in 2022 by sector (number of companies)

The industry with the most foreign subsidiaries was infrastructure and construction, with 13.1% of the total number of companies.

The sector of ICT and digital transformation of industry (with 897 foreign subsidiaries) and the machinery and capital goods sectors (with 658 foreign subsidiaries) represent 17% of foreign subsidiaries in Catalonia, which positions Catalonia as a driving force for Industry 4.0 for foreign companies as well.





## Foreign subsidiaries in Catalonia by value chain

Foreign subsidiaries in business represented 31.2% of the total, and invoiced 41.1% of the total. Foreign subsidiaries in services represented 27.5% of the total, and invoiced 13.9% of the total. Foreign subsidiaries in manufacturing represented 11.8% of the total, and invoiced up to 27.6% of the total.

# 4. Countries of origin and location in Catalonia of foreign subsidiaries



## Distribution by country of origin of foreign subsidiaries in Catalonia in 2022

The 9,155 foreign subsidiaries in Catalonia in 2022 came from 90 different countries.

90.4% of foreign subsidiaries in Catalonia come from the 20 countries on the list. The weight of subsidiaries of companies from France, Germany, the United States, the United Kingdom and Italy stands out. Taken together, they represent 57.7% of the total.

## Distribution by geographic area of origin of foreign subsidiaries in Catalonia, 2022

Europe is the area of origin of 3 out of 4 foreign subsidiaries in Catalonia.

Compared to 2019, there was notable growth in North and South America, and more moderate growth in Asia and Europe.


